# A Message of Strength In a Time of Crisis

While we can't change what's going on in the world, we can make a difference! For those who have suffered from abuse, the issues do not pause or take a break even during the declared National Emergency for COVID-19.

Domestic violence survivors may be experiencing increased isolation and danger caused by confinement during the pandemic. Likewise, as has been nationally reported, others are experiencing abuse for the first time, brought on by the sudden economic downturn and uncertainty. Many of these individuals were already vulnerable to financial and health insecurity, and are now experiencing additional challenges. The Retreat is ready to help.

We want to be clear that the agency is open. To ensure clients are supported we have taken specific steps to maintain access for those in need:

- The 24-hour Hotline is operational, with access to multiple languages. (631)329-2200 or Deaf Crisis Line (321)800-3323
- Counselors are available for phone sessions.
- Advocates will continue to educate clients on their rights.
- Our emergency shelter remains operational, with safety protocols in place.
- Educators are teaching via video-conferencing for middle and high schoolers learning remotely.
- And, administrative functions are being done by employees working from home.

During the past three decades, The Retreat has acquired outstanding experience implementing a full continuum of domestic violence services as well as prevention strategies. We believe this experience has provided us with outstanding connections and the leadership capacity to carry us through this crisis.

We will continue to be here, remotely or in-person, for anyone who reaches out for help.

The Retreat has one attorney on staff, two part-time attorneys and pro-bono support. In addition, Retreat Advocates made 744 trips to court.



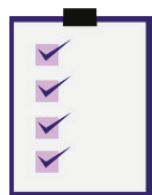
